Telecommunications Technicians, without direct supervision, will install, test and maintain telecommunications systems, including but not limited to intercommunication systems, telephone voice over IP systems, PBX, voice and data-switching systems, major operations computers, supervisory, power and telephone line carriers, microwave, SCADA Control systems, fiber optics, multiplex, radio – both voice and data, remote signal and remote control equipment, load frequency control, telemetering equipment, power systems including UPS, DC chargers and large battery banks. Must be able to trouble shoot from basic electronic schematics. Must use and maintain communication circuit prints. May be required to investigate, correct, or make recommendations to



correct user station equipment, personal computers and related equipment problems, as well as radio and television interference complaints. May be required to install protective grounding on power systems.
